

# Student Parent Child Care Funding Program Graduate Student Child Care Grant (GSCCG) 2017/18 Fact Sheet

# Who is eligible to receive the grant?

UC Davis students enrolled full-time in a graduate or professional degree program or on filing fee status (one term allowed). Students must claim *and reside with* (at least half time) dependent children 12 years old or younger and must incur child care expenses.

#### *Not Eligible for GSCCG:*

- Undergraduate Students
- Postdocs, Medical and Veterinary Residents
- Students in self supporting programs.
- Visiting Students

#### How much is the grant?

The GSCCG is a per UCD student, per term flat award of up to \$900 per quarter (\$1350/semester). It is not based on financial need and all grad/prof students with documented child care expenses are eligible for this grant...If the actual cost of care does not reach \$900 for the quarter (\$1350/semester), you will not receive the surplus. Please keep a copy of your actual expenses as we may audit.

### What if both parents are graduate students?

The GSCCG is tied to the UCD student, not the child. Graduate/Professional student couples may each receive funds for the same child's care, but not the same documented hours of care.

# What qualifies as a "Child Care Provider"?

Family child care homes, centers, after-school programs, nannies, friends, neighbors and relatives. A child's parents are not considered "child care providers." Private elementary schools, including kindergarten, are not eligible. Recreation programs are not eligible during the academic year. Exceptions for week-long, multi-hour camps and youth programs are made for summer.

#### What about other Child Care Funding?

- All graduate/professional students with child care expenses should apply for the GSCCG. The GSCCG is not based on financial need.
- A graduate/professional student who demonstrates
  financial need may be eligible to receive a supplemental
  grant through the Community Based Care Grant (CBCG).
  This program, not available for summer, provides funds
  per child minus any funds received through the GSCCG.

Student (US Residents) Supplemental Application for Community Based Care Grant (CBCG), and a copy of your My Awards page or SAR. If an International Student, submit the International Student
Supplemental Application For Community Based Care Grant and a copy of your I-20 or DS-2019. Your GSCCG application will be kept on file so if you want to apply for CBCG at a later date during the academic year, you only need to submit the supplemental application.

### How and when to apply:

- Applications are available in June for the next fiscal year (July 1), accepted on an ongoing basis, and are posted at <a href="http://worklife-wellness.ucdavis.edu/">http://worklife-wellness.ucdavis.edu/</a> family care/children/childcaresub.html
- You may apply for current (up to last instruction day of term) and/or future terms. *If* you plan to be enrolled for the entire year, you may apply in Summer for Summer, Fall, Winter and/or Spring. Separate "Section Bs" are required for each child care provider you employ. You are responsible for reporting all changes to the WorkLife office. *Retroactive funding for terms which have passed is not available.*
- If you are or will be on filing fee status, please indicate the term on your application or inform us as funds will not disburse without a manual override for enrollment.
- You may submit your application materials 3 ways:

#### How will I receive the grant?

Funds will be credited into your student account. Once approved, they take about 2-3 weeks to disburse. Funds for subsequent terms are disbursed the first week of each term. If you have unpaid charges on your account, funds may be absorbed to offset them. To expedite the process, please visit the Student Accounting <a href="weebpage">webpage</a> to set up direct deposit. Grants are reportable income and you will be issued a 1098T by the University. It is your responsibility to pay the child care provider identified on your application.
