\$3,500 in student wages for EMT services posted in the 2023-24 fiscal year instead of 2022-23.

A different model of budgeting labor for the entire Division of Student Affairs was implemented for the 2023-24 fiscal year which resulted in a higher than needed allocation for the student salaries. Any unexpended portion of the budgeted student salaries will be reallocated to cover the facility rental costs.

Cal Aggie Camp's facility rental expense was previously grouped under "c. Programs, Information Technology,

Administration" in the 2022-23 worksheet but is now listed under "d. Facility/Maintenance Expenses". Facility costs for 2023-24 is estimated at approx. \$52,100, however only a portion (approx. \$34,885) will be funded from the ASUCD Fee due to exhausting current available funds including reserves. The remaining amount (estimated \$17,215) will have to be covered from Cal Aggie Camp donations.

The remaining reserves balance will be used to cover a portion of Cal Aggie Camp's facility rental cost.
