1. Please describe the department's programs, services and/or facilities funded by the ASUCD Fee, EOP.

The funding is primarily used to support EOP's high touch program The Special Transitional Enrichment Program (STEP) begins as a 6-week pre-matriculation residential program for first generation, low-income students. Since 2019 we have gradually increased the number of students who participate in the program. During the academic year the program provides peer mentoring, tutoring and academic counseling.

Please provide information on any substantial variance between 2023-24 and 2024-25: Salaries for both student employees and professional career staff have been adjusted to accurately reflect the true operational costs associated with the STEP program. This adjustment aligns with the program's growth to accommodate a larger number of students. Despite these rising costs, we remain committed to maintaining STEP as a cost-free program for students, ensuring that financial barriers do not hinder access to the valuable resources and support the program provides.

The majority of STEP expenses are incurred during the summer, with costs beginning to accumulate in the spring as we prepare to support the program. All final summer-related expenses will be reflected in the ledger by October. These expenses include compensation for peer staff, summer housing costs, and covering any remaining balances not covered by financial aid.

**4.** Please provide information on the scope of student use of the programs/services/facilities funded by the ASUCD Fee, EOP.

The current funding supports 174 first-year students and 179 second-year students. Additionally, a portion of the funds is allocated to hosting a graduation reunion for STEP students, with an estimated 160 graduates expected to participate.
