Please provide your comments regarding the **Women's Resources & Research Center** presentation and use of the Student Activities & Services Initiative (SASI) fee.

# Please provide your comments regarding the **Campus Recreation** presentation and use of the Student Activities & Services Initiative (SASI) fee.

The use of the SASI fee at the campus recreation is a critical resource for all the students. It offers students the opportunity of employment and a variety of programs to ensure good health.

Campus Rec plays a vital role in student life. My only note is that it would be nice if, in the future, their presentation could focus more on their usage of SASI fees vs what Campus Rec does in general. Originally we could not get a clear answer as to why their carryforward was so high and why their facility/maintenance costs went up almost 100%. However, at this last meeting, Deb was able to bring clarity to our questions and concerns.

Campus Recreation serves many students on campus and uses the SASI fee as best as they can given the rapid changes to equipment and/or conditions of facilities. For future presentations, it would be beneficial to have a thorough break down of what the SASI fee is specifically used for and the timeline of projects to better understand the ways students' money supports Campus Rec.

The Campus Recreation presentation was very informative, and I liked how all of the expenses are transparent and fully reflected. It is obvious that the SASI fee is necessary and instrumental in keeping the campus recreation operational.

The presentation clearly showed the spending and it explained the future projects. I appreciate the presentation mentioning the though behind future projects.

I think Campus Rec's use of the SASI fee is being done appropriately and for the benefit of the students.
