Legal Education Enhancement and Access Program (L.E.E.A.P.)

- **Voting** - The voting procedures shall be consistent with the Law Students Association Constitution and the University of California, Davis Policy and Procedures Manual 280-15(IV)(C)(3) for the purposes of minimum voting requirement. The minimum voting requirement shall be determined jointly by the Law Students Association President and the Office of the Dean of the Law School.
- **General Fee Principle** - Funds collected through the L.E.E.A.P. Initiative are designed to be phased-in to ensure that only students who have access to new facilities will be required to pay fees supporting the facility.
- **Planning and Oversight** - The funds shall be overseen as follows:
 - **Law Student Recreation Fund** - Law Students Association; one-half of the funds shall be transferred to the Intramurals and Sports Clubs department, for ongoing support of the intramurals and sports clubs program.
 - **Recruitment, Retention and Outreach** - Law Students Association Board, which shall, in conjunction with the Office of the Dean, develop procedures to ensure participation by representatives of student organizations and the Admissions Office in the governance of the funds.
 - **Law School Financial Aid** - Law Students Association, which shall, in conjunction with the Office of the Dean, develop procedures to ensure participation by representatives of the King Hall Legal Foundation and the Law School Financial Aid Office in the governance of the funds. In any year, not less than 60% of the funds collected through the Law School Financial Aid fund shall be transferred to the Loan Repayment Assistance Program (LRAP).
 - **Recreation Hall Enhancements, Activities and Recreation Center, Aquatics Complex, Multi-Use Stadium, and Equestrian Center Enhancements** - Funds collected for these purposes shall be administered by the campus-wide committee charged with implementing the Facilities And Campus Enhancements Initiative (F.A.C.E.), which shall include law student representation, unless the Law Students Association Board waives such participation.
- **Implementation** - Upon passage of this initiative, the text shall be forwarded by the Office of the Dean to the Office of the Vice Chancellor for Student Affairs and the Chancellor, for transmission to the Board of Regents. The Law Students Association President and the Office of the Dean, or their designees, shall jointly coordinate the implementation of the fee, including the mechanism by which funds for dedicated purposes shall be transferred.
- **Accountability** - The Treasurer of the Law Students Association shall annually make available, upon request, an accounting of all funds designated as governed by the Law Students Association and appropriated pursuant to provisions of this initiative.
- **Earned Interest Income** - All interest income earned from fees generated by this initiative shall be made available to spend on the projects described in the ballot.
- **Adjustment of Fees** - More than 75% of these fees are collected to fund capital projects. Project scope and cost will be adjusted as necessary to insure that these fees will cover the debt financing for these capital projects. The balance of these fees will fund operating expenses that are expected to change over time. The portion of the fees collected for operating expenses will be tied to an appropriate consumer price index to be determined by the appropriate oversight body and may be adjusted accordingly (up or down) on an annual basis by the oversight body. ***No adjustments shall be made prior to the 2004-05 academic year.***

Attached is a proposed Regents' Agenda Item for establishment of a Legal Education Enhancement and Access Program Fee. The fee would be phased as follows: \$15.50 per student per semester effective Fall Semester 1999, increasing to \$27.00 per student per semester effective Fall Semester 2000, increasing to \$30.00 per student per semester effective Fall Semester 2001, increasing to \$33.00 per student per semester effective Fall Semester 2002, and increasing to \$183.50 per student per semester effective Fall Semester 2003 and thereafter (subject to annual adjustment for inflation).

On April 14-15, 1999, elections were held by the Law Student Association, Davis campus, proposing approval of a fee to support law student services, recruitment, retention, outreach, recreation, and campus recreation facilities. The proposed fee passed in accordance with the conditions established by campus policy.

ESTABLISHMENT OF LEGAL EDUCATION ENHANCEMENT AND ACCESS PROGRAM FEE,
DAVIS CAMPUS

The President recommends that the Committee on Finance recommend to The Regents that effective Fall Semester 1999, a mandatory Legal Education Enhancement and Access Program Fee be assessed all students in the School of Law at the Davis campus. The fee would be phased as follows: \$15.50 per student per semester effective Fall Semester 1999, increasing to \$27.00 per student per semester effective Fall Semester 2000, increasing to \$30.00 per student per semester effective Fall Semester 2001, increasing to \$33.00 per student per semester effective Fall Semester 2002, and increasing to \$183.50 per student per semester effective Fall Semester 2003 and thereafter.

BACKGROUND

In April 1999, elections were held by the Davis campus Law Student Association (LSA) to seek approval of a fee to support law student services, recruitment, retention, outreach, recreation, and campus recreation facilities. Students approved a fee of \$183.50 per student per semester, with the following provisions:

1. Implementation of the fee will be phased as follows: \$15.50 per student per semester effective Fall Semester 1999, increasing to \$27.00 per student per semester effective Fall

Semester 2000, increasing to \$30.00 per student per semester effective Fall Semester 2001, increasing to \$33.00 per student per semester effective Fall Semester 2002, and increasing to \$183.50 per student per semester effective Fall Semester 2003 and thereafter (subject to annual adjustment for inflation).

2. The fees will be allocated as follows:

3. Fees will not be collected until the service can be delivered to the students paying the fees. If the capital projects are not completed and open to students within the timetable outlined above, assessment of the fee will be delayed accordingly.
4. Effective Fall Semester 1999, law students will have access without payment of user fees to the Recreation Hall and Intramural Sports programs, excluding special events, and to regular season athletic events.
5. The funds shall be overseen as follows:

- a. The Law Student Recreation and Intramurals Fund shall be overseen by the LSA. One-half of the funds shall be transferred to the Intramurals and Club Sports department, for ongoing support of the intramurals and sports clubs program.
 - b. Funds for recruitment, retention and outreach shall be overseen by the LSA Board, which shall, in conjunction with the Office of the Dean, develop procedures to ensure participation by representatives of student organizations and the Admissions Office in the governance of the funds.
 - c. The Law School Financial Aid Fund shall be overseen by the LSA, which shall, in conjunction with the Office of the Dean, develop procedures to ensure participation by representatives of the King Hall Legal Foundation and the School of Law Financial Aid Office in the governance of the funds. In any year, not less than 60% of the funds collected through the Law School Financial Aid Fund shall be transferred to the Loan Repayment Assistance Program (LRAP).
 - d. Funds collected for Recreation Hall enhancements, the Activities and Recreation Center, Aquatics Complex, Multi-Use Stadium, and Equestrian Center Enhancements shall be administered by the committee charged with oversight of the Facilities and Campus Enhancements (FACE) Initiative, which shall include law student representation, unless the LSA Board waives such participation.
6. The LSA President and the Dean, or their designees, shall jointly coordinate the implementation of the fee, including the mechanism by which funds for dedicated purposes shall be transferred.
 7. The Treasurer of the LSA shall annually make available, upon request, an accounting of all funds designated as governed by the LSA and appropriated pursuant to provisions of this initiative.

8. All interest income earned from fees generated by this initiative shall be made available to spend on the projects described in the ballot.
9. The portion of the fee that supports operating expenses may be annually adjusted upward or downward to reflect fluctuations in an appropriate consumer price index, to be determined by the committee charged with oversight of the FACE Initiative. No adjustments shall be made prior to the 2004-05 academic year.

Prior to the referendum, the campus required a minimum voter turnout of 210 students to establish this fee. This number was derived from a formula based on past voter turnouts in LSA elections. The campus also prescribed that a majority of those voting would determine whether a fee would be established.

Of the 516 eligible students, 240 voted and 166 (69%) voted in favor of the fee. These results meet the requirement of voter turnout and majority approval.

- Support of the **King Hall Legal Foundation's (KHLF) Summer Grants Program**.
- **Free Law Student Access to Recreation Hall and Intramural Sports** effective Fall Semester, 1999, excluding special events. Graduate/Professional Students will also have free admission to regular season UC Davis athletics events (such as soccer, football, basketball, etc.) at that time and thereafter.
- A state-of-the-art **Activities and Recreation Center** (to complement Recreation Hall) designed to address the following:
 - Meeting and practice/performance spaces and a dance studio for student organization use;
 - Spaces for recreational and IM student use;
 - Instrument and equipment storage and changing space for the Cal Aggie Maching Band-Uh!;
 - Lounge, art gallery and computer access space;
 - Space for weights and aerobics, plus mat space and 4-wall courts;
 - Locker rooms, showers, storage space and office space.
- Funding for **Sport Clubs and/or Intramural Sport Programs**, including maintaining free access to equipment for the King Hall softball league.
- **Recreation Hall** improvements and equipment.
- A new **Aquatics Complex** containing an Olympic-size competition pool and diving facilities.
- Partial funding for a **Multi-Use Stadium** (the balance of funding will come from non-student-fee sources).
- Enhancements to the **Equestrian Center**, including health and safety improvements and a new covered arena.

Legal Education Enhancement and Access Program (L.E.E.A.P.)

- **Voting** - The voting procedures shall be consistent with the Law Students Association Constitution and the University of California, Davis Policy and Procedures Manual 280-15(IV)(C)(3) for the purposes of minimum voting requirement. The minimum voting requirement shall be determined jointly by the Law Students Association President and the Office of the Dean of the Law School.
- **General Fee Principle** - Funds collected through the L.E.E.A.P. Initiative are designed to be phased-in to ensure that only students who have access to new facilities will be required to pay fees supporting the facility.
- **Planning and Oversight** - The funds shall be overseen as follows:
 - **Law Student Recreation Fund** - Law Students Association; one-half of the funds shall be transferred to the Intramurals and Sports Clubs department, for ongoing support of the intramurals and sports clubs program.
 - **Recruitment, Retention and Outreach** - Law Students Association Board, which shall, in conjunction with the Office of the Dean, develop procedures to ensure participation by representatives of student organizations and the Admissions Office in the governance of the funds.
 - **Law School Financial Aid** - Law Students Association, which shall, in conjunction with the Office of the Dean, develop procedures to ensure participation by representatives of the King Hall Legal Foundation and the Law School Financial Aid Office in the governance of the funds. In any year, not less than 60% of the funds collected through the Law School Financial Aid fund shall be transferred to the Loan Repayment Assistance Program (LRAP).
 - **Recreation Hall Enhancements, Activities and Recreation Center, Aquatics Complex, Multi-Use Stadium, and Equestrian Center Enhancements** - Funds collected for these purposes shall be administered by the campus-wide committee charged with implementing the Facilities And Campus Enhancements Initiative (F.A.C.E.), which shall include law student representation, unless the Law Students Association Board waives such participation.
- **Implementation** - Upon passage of this initiative, the text shall be forwarded by the Office of the Dean to the Office of the Vice Chancellor for Student Affairs and the Chancellor, for transmission to the Board of Regents. The Law Students Association President and the Office of the Dean, or their designees, shall jointly coordinate the implementation of the fee, including the mechanism by which funds for dedicated purposes shall be transferred.
- **Accountability** - The Treasurer of the Law Students Association shall annually make available, upon request, an accounting of all funds designated as governed by the Law Students Association and appropriated pursuant to provisions of this initiative.
- **Earned Interest Income** - All interest income earned from fees generated by this initiative shall be made available to spend on the projects described in the ballot.
- **Adjustment of Fees** - More than 75% of these fees are collected to fund capital projects. Project scope and cost will be adjusted as necessary to insure that these fees will cover the debt financing for these capital projects. The balance of these fees will fund operating expenses that are expected to change over time. The portion of the fees collected for operating expenses will be tied to an appropriate consumer price index to be determined by the appropriate oversight body and may be adjusted accordingly (up or down) on an annual basis by the oversight body. **No adjustments shall be made prior to the 2004-05 academic year.**
