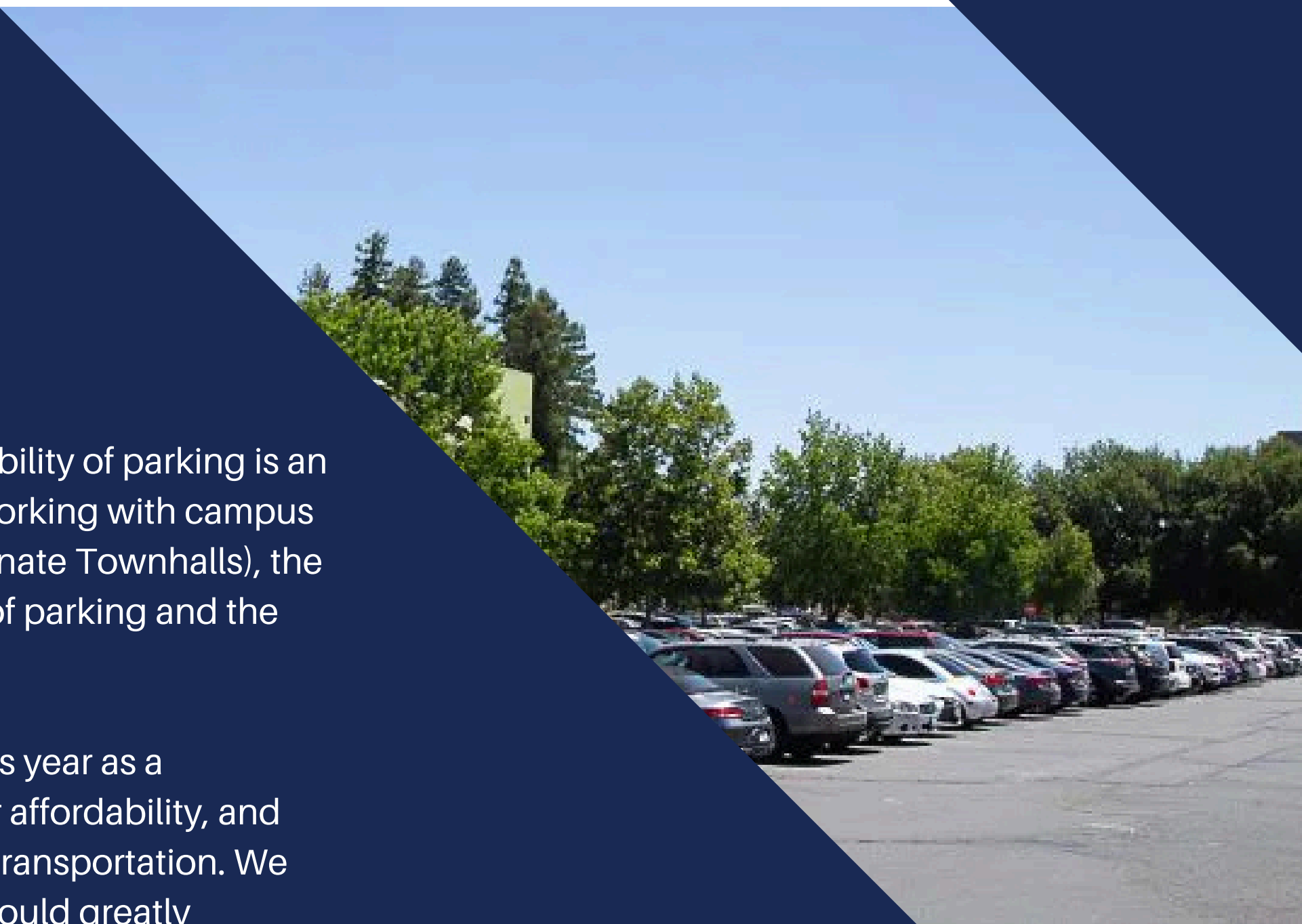

Introduction

Students have indicated that the cost and accessibility of parking is an issue that they would like ASUCD to address by working with campus partners. On public forums (online and ASUCD Senate Townhalls), the discussion has centered around the affordability of parking and the belief that parking policies are opaque.

ASUCD created the Equitable Parking Initiative this year as a campaign to combat misinformation, advocate for affordability, and incentivize the use of more sustainable modes of transportation. We believe that the Sustainable Transportation Fee would greatly advance these objectives.

COMBATTING MISINFORMATION

Providing a countercultural narrative to students by provoking thoughtful discussions about parking at UC Davis



AFFORDABILITY

Ensuring that students that are forced to drive are able to afford associated costs and that driving is generally affordable



SUSTAINABILITY

Investing in bike education programs, promoting bike safety, and renovating infrastructure to account for e-scooters

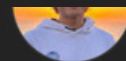

AFFORDABILITY

- **ASUCD Transportation Grant**
 - Provides up to \$250 to help cover transportation-related costs for eligible undergraduate students
 - Centered around experiences of low-income commuters, student parents, international, and undocumented students
 -
- **Sustainable Transportation Fee**
 - Increased funding for Transportation Grant
 - Stabilized daily parking rates
 - Reduced citation fees (\$64 -> \$50)

Transportation Tomorrow Goals

- Reduce single-occupancy vehicle (SOV) commuting by 10% by 2025 and 30% by 2050.
- Develop and promote active transportation programs (e.g., walking, biking).
- Expand transit and shuttle services for better regional connectivity.
- Foster carpool and vanpool programs.
- Reduce the campus's carbon footprint by minimizing vehicle miles traveled (VMT).
- Create safer, more enjoyable pedestrian and cycling networks.
- Enhance wayfinding and incorporate safety features like lighting and emergency phones.

Transportation Tomorrow Goals

- Explore autonomous vehicle options, ride-sharing partnerships, and dynamic pricing systems to support mobility goals.
- Establish a unified portal for parking, mobility options, and incentives, making transportation choices easier for users.
- Encourage telework and flexible schedules to reduce commute pressures.
- Promote a shift in mindset away from reliance on single-occupancy vehicles.
- Free up land and financial resources by reducing parking demands and focusing on mission-critical activities like education, research, and healthcare.
- Involve diverse campus groups in planning and implementing mobility solutions.

The Sustainable Transportation Fee aims to provide a revenue stream for Transportation Services' sustainability programs (e.g. Bike registration, Lit Not Hit, Helmet Hair Don't Care), create an annual transportation grant for populations negatively impacted by daily parking rates, and ensure a stabilization of the daily parking rate. It will expire in AY 2029-2030 unless action is taken by students to renew it.

Generating and publicizing a report that provides a comprehensive overview of the impact of expenditures on expanded transit services, active transportation initiatives, and emerging mobility technology

BI-ANNUAL PRESENTATIONS TO STUDENTS

Mandating the Board to hold a public forum twice a year to engage with students and present data on the impact of the fee on sustainable transportation at UC Davis
