Last year we were severely short staffed. Most of the year was focused on hiring a Director and 3 program coordinators. These positions were hired and onboarded during the end of spring quarter 2022. We adjusted the amount of programming and services provided that was manageable for a team of 2 career staff. They also prioritized the use of one time funds, knowing the SASI funds could be rolled forward and kept in house.

As of today, we have a full staff to help rebuild and plan a full load of programming for the 2022/2023 academic year and beyond.

Event costs have risen higher than the average of inflation. The request for consumer price index funding will help us continue to provide support for the growth of programs and services towards the seven communities that the CCC serves. If the consumer price index is not received these programs will have to rely on the reserve funds remaining and reduce operational costs and programing to these areas.

For this year, we expect to host our cultural days events at full capacity to enhance the student experience. We will have to adjust our budget to accommodate the costs of goods and services, labor expenses and vendor fees.

Our mission at the Cross Cultural Center (CCC) at UC Davis is to work towards a more just and liberated world.
